### Summary of Month Activities

### 1/5/2025

On Sunday, January 5<sup>th,</sup> Detective Danielle Campbell and Deputy Joseph Lodwick received a call via cell phone of a disturbance at 637 Royal Street at approximately 9:35 AM. The owner of the business complained that the known subject, Armando Calderon, was outside of the business yelling profanities at people and demonstrating unstable behavior by walking towards oncoming cars. Detective Campbell observed Mr. Calderon sitting across the street from the business Fisher Gambino's and approached and asked him to move to another location repeatedly before he finally complied. Detective Campbell and Deputy Lodwick then made a loop around Saint Louis Cathedral into Jackson Square where Calderon was spotted again. At this time, Mr. Calderon pointed at Detective Campbell and screamed profanities at her. Bystanders in the immediate vicinity became startled and hurriedly departed the area out of apparent fear that Mr. Calderon would escalate his behavior. Detective Campbell then ordered Mr. Calderon to exit Jackson Square, and he refused to comply. Detective Campbell further explained to Mr. Calderon that if he failed to move on, he would be placed under arrest for disturbing the peace. Mr. Calderon refused and stated that he was not afraid and prepared to go to jail. Detective Campbell placed Mr. Calderon in handcuffs and escorted him to the Eighth District station. It was additionally discovered that Mr. Calderon had two outstanding attachments, which were later verified via NCIC. OPSO Sgt. Jamil Champagne and OPSO Detective Anthony Wiltz transported the arrested subject to central lock up, where he was booked accordingly.

### 1/15/2025

On Wednesday, January 15, 2025, at approximately 10:50 AM, Deputy Loy Madrigal was conducting a routine foot patrol in the 400 block of Royal Street. During his patrol, Deputy Madrigal observed a male subject sitting on the corner of Saint Louis Street and Royal Street, appearing to be rolling a green leafy substance. Deputy Madrigal approached the subject, who was later identified as Dejuan Pichon (DOB: 06/02/1991), and asked what he was rolling. The subject admitted he was rolling a blunt of marijuana. Deputy Madrigal informed Pichon that possession and smoking of marijuana in public is illegal under New Orleans Municipal Ordinance. Deputy Madrigal instructed the subject to dispose of the marijuana, but Pichon refused. The deputy explained that the subject could be issued a summons for possession of marijuana under Municipal Code Section MCS 271 54.505. The subject became confrontational and raised his voice, causing alarm to nearby pedestrians. When asked for his identification, the subject refused to comply. Deputy Madrigal advised that failure to provide identification could result in detention for identification purposes. The subject continued to refuse, prompting the deputy to detain him and notify NOPD dispatch. The subject was escorted to the Eighth District station, where Deputy Madrigal read him his Miranda rights. Initially, the subject continued to refuse to provide his identity. After being informed that he would be transported to Central Lock-Up if he did not comply, the subject finally provided his identification, which was located in his wallet. During the arrest, Deputy Madrigal searched a black bag in the subject's possession and discovered a small, clear plastic bag containing a green leafy substance believed to be marijuana. The substance was confiscated and submitted to the evidence room for processing. The subject was charged with the following municipal violations: MCS 271 54.505 – Possession of Marijuana and MCS 271 54.403 – Disturbing the Peace. The subject was issued a municipal summo
