Summary of Month Activities

2/7/2025

On Friday, February 7, 2025, at approximately 10:00 AM, Deputy Loy Madrigal was conducting foot patrol in the 300 block of Royal Street when he observed a small group of protesters gathered in front of Brennan's Restaurant, located in the 400 block of Royal Street. Deputy Madrigal immediately notified dispatch about the protest and proceeded toward Brennan's to provide police visibility and ensure public safety. Upon arrival, Deputy Madrigal observed additional deputies from the Orleans Parish Sheriff's Office already present outside the restaurant. He made contact with one of the protesters, who identified themselves as a representative of PETA (People for the Ethical Treatment of Animals). The protest remained peaceful, and at approximately 10:40 AM, the protesters dispersed from the area without incident. No disturbances, arrests, or violations were reported during the event.

2/19/2025

On February 19, 2025, at approximately 1:15 PM, while on patrol in the 300 block of Royal Street, Deputy Madrigal heard via dispatch that an NOPD officer at 1241 Decatur Street required assistance. The officer had a subject at gunpoint and requested backup. Deputy Madrigal immediately advised dispatch that he was en route. Upon arrival at the location, two male subjects had already been detained by NOPD officers. Additionally, a male victim was observed to have a bleeding injury to one of his fingers. Deputy Madrigal promptly rendered aid to the injured victim by applying gauze and direct pressure to control the bleeding. After providing medical assistance, Deputy Madrigal remained on scene to assist NOPD officers as they conducted their investigation. Once the situation was stabilized, Deputy Madrigal ensured that no further assistance was required before clearing the scene.

2/20/2025

On Thursday, February 20, 2025, at approximately 5:10 PM, Deputy Madrigal was in the 400 block of Royal Street when he heard a radio dispatch regarding a white male screaming on the corner of Dauphine and Burgundy Streets. Deputy Madrigal responded to the call to provide backup to a responding NOPD officer. Upon arrival at the scene, Deputy Madrigal observed a white male wearing a red jersey who appeared to be experiencing a mental health crisis. The subject then walked into a nearby business establishment. Deputy Madrigal and the NOPD officer followed the subject inside and issued verbal commands instructing him to step outside. The subject complied and was engaged in conversation; however, he exhibited a combative demeanor. For the safety of the subject and those around him, Deputy Madrigal and the NOPD officer detained the individual. The subject was subsequently transported to a hospital for further evaluation. No further incidents were reported.

Summary of Month Activities

2/22/2025

On Saturday, February 22, 2025 at approximately 8:15 PM, Detective Neil Madrigal, assigned to the Investigative Service Bureau, and Deputy Loy Madrigal, assigned as Executive Protection, while working an approved off-duty detail for the Bourbon Promenade, responded to a call for assistance in regards to a customer detained by a Probation and Parole (P&P) Agent who was working an off-duty detail at the Hard Rock Café located at 125 Bourbon Street. Upon arrival, Detective Madrigal observed the defendant, later identified as Tamika M. Dauzart, sitting on the ground by the lberville Street entrance of the restaurant, detained by P&P Agent Mike Moore. Detective Neil Madrigal and Deputy Loy Madrigal spoke to the Assistant Manager, later identified as David Fulcher, who explained about the incident. The victim, later identified as Jasmine Ashontae Davis, stated that she was trying to give Ms. Dauzart a refund for items that she purchased. Ms. Dauzart then became irate and approached Ms. Davis on the side of the register counter. Ms. Davis told Ms. Dauzart to get back and Ms. Dauzart did not comply. Ms. Davis then pushed Ms. Dauzart away from making advances to her. At that time, both individuals ensued into a physical altercation. Ms. Dauzart bit Ms. Davis's left index finger. On surveillance footage, Ms. Dauzart is observed striking Ms. Davis after Ms. Davis attempts to push Ms. Dauzart away. Detective Neil Madrigal then arrested Ms. Dauzart and escorted her to the 600 block of Conti Street where the temporary Orleans Parish Sheriff's Office Booking and Processing station is established. Ms. Dauzart was searched, medically evaluated, and processed. Detective Neil Madrigal charged Ms. Dauzart for Louisiana Revised Statute (LA. R.S.) 14:35 relative to Simple Battery under NOPD Item Number B-21435-25. At approximately 8:45 PM, Detective Lakesha Sutherland, discovered 21 packets of Suboxone on Ms. Dauzart, who did not have a prescription for the Suboxone. Detective Neil Madrigal rebooked Ms. Dauzart under NOPD Item Numbe
